

General Information and Terms and Conditions

RESERVATIONS, DEPOSITS AND FINAL PAYMENTS: To confirm your reservations, a \$450.00 per person deposit will be required **and will cover your trip/cancellation insurance as well.** Your final payment **will** be due 91 days **prior** to departure (January 22, 2008) and should be made by check. If you prefer to pay your final payment by credit card there will be an additional 3% fee added to your fare.

SERVICE FEE: There is a \$25.00 service fee for group reservations once under deposit. Airline changes are subject to an additional \$100.00 fee. Airline tickets are non-refundable at time of ticketing but can be re-used with a service fee within one year from date of purchase. Please be sure to give us your name as shown on your passport!

CANCELLATION/REFUNDS:

Full refund less a \$25.00 per person handling fee applies if cancellation is **made** more **than** 91 days **prior** to departure. Thereafter, the per person cancellation fees on the land arrangements are as follows:

90 -61 days or more prior to departure - \$125.00 charge per person plus the optional insurance premium

60-30 days prior to departure - 50% charge per person plus the optional insurance premium

29-0 days prior to departure - 100% charge per person plus the optional insurance premium

The above cancellation fees are covered by the trip cancellation/medical insurance if cancellation is for a covered reason. Call for a detailed insurance brochure.
